# **INSPIRE Strategy 6 – Response and Support**

## Why the need for Barnahus?

Investigating cases of child abuse requires close cooperation between different agencies involved – police, health sector, judiciary, child protection agencies. In practice such examples of effective multi-agency cooperation were rather exceptional, resulting in a long and traumatic process for a child that is a victim or witness of abuse or violence:

- Multiple interviews in different locations by staff that is not trained to work with children
- Months of waiting for a trial and appeals
- Hostile cross-examination
- Lack of proper medical examination and therapeutic services for victims

### Barnahus as a response

Innovating on the US approach, the first Barnahus was established in Iceland in 1998, as a child-friendly, multiagency response to child abuse, providing necessary services often under one roof:
