## Call for Tenders

**Contracting party:** Terre des Hommes Foundation “Lausanne” in Hungary

**Tender reference:** HUN-24-034-CP

### **Introduction**

Terre des hommes has over the past years created several Drupal-based websites to disseminate information to various actors in support of child protection activities. Thanks to the success of these websites, the development and maintenance needs continue to grow. We are therefore seeking to appoint regular service providers to streamline these activities through this Call for Tenders.

### **Financing**

The activities in scope are funded by the Foreign, Commonwealth and Development Office (FCDO), SOMAHA Foundation, The European Union, UEFA and potentially other private foundations.

The beneficiary of the funding is the Terre des hommes Foundation, Switzerland or its office in Hungary, Terre des hommes Foundation “Lausanne” in Hungary (Tdh HU).

## 1. General instructions

- 1.1 These instructions to Tenderers set out the rules for the submission, interaction between parties and implementation of subsequent actions under this Call for Tenders.
- 1.2 The Tenderer will bear all costs related to the preparation and submission of its tender (visits, on-site inspection, etc.). The contracting authority will not be responsible or liable for any costs incurred by the Tenderer, regardless of the progress or outcome of the procedure.
- 1.3 Terre des hommes retains ownership of all bids received in this tender procedure. Consequently, bidders may not demand that their bids be returned to them.
- 1.4 The evaluation committee reserves the right to reject any file deemed insufficiently complete at the time of the evaluation of the offers.

## 2. Services to be provided / Works to be carried out

- 2.1 The purpose of this Call for Tenders is to solicit competitive bids for Drupal website development, support, some webdesign, website maintenance and security, and website development advisory services for several websites, the biggest among them are: childhub.org, safeguardingsupporthub.org, uefa.safeguarding.org, lokallink.org, and tdh-europe.org. The tasks also include working on moodle (setting up moodle environment, supporting learners with technical issues, creating certificates, collecting data for reporting) as Tdh is developing e-learning courses (delivered as scorm files).
- 2.2 Through this Call for Tenders Tdh intends to appoint multiple partners by entering into contracts that are valid for one year and renewable for a second year.
- 2.3 **The Terms of Reference with detailed documentation are included in Annex 1 and Annex 2.**
- 2.4 The quantities mentioned in this document are estimates and can in no way be considered as a firm commitment on the part of Tdh.
- 2.5 The Tenderer undertakes to maintain the prices offered for the entire duration of the contract (**12 months**). The prices may be renegotiated at the end of the Framework Contract, if TdH and the Service Provider wish to extend the contract.

Payment shall be made on delivery with monthly invoicing for ad-hoc and continuous support activities made by wire with 15 days net from date of invoice.

## 7. Presentation of the offer

- 7.1 Tenders, associated documents and correspondence between the Tenderer and Tdh must be written in the language of the procedure, which is English.
- 7.2 The financial offer must cover all services described in **Annex 1** and must be expressed without VAT in Euros. Please consider the necessary set-up / origination costs and propose budget-split for these.
- 7.3 **Tenders must be received by 20/May/2024 16.00 pm CET.** Late tenders will be rejected and will not be evaluated. Nevertheless, all tenders received after the submission deadline will be retained by the contracting authority.
- 7.4 All tenders must be submitted by email to the [Hun.Tenders@tdh.org](mailto:Hun.Tenders@tdh.org) mailbox.
- 7.5 The subject of the email should be as follows:
  - a) Call for Tender Ref. No. HUN-24-034-CP.
  - b) "Not to be opened before the opening session of the offers".



## 8. Contents of the offers

All tenders submitted must comply with the requirements of the tender dossier and the package submitted by the Tenderer must contain at least the following documents. Bidders who do not provide all below documents and in the format requested may be excluded from the selection process.

## 9. Questions and clarifications regarding the tender dossier

- 9.1 If Tdh, on its own initiative or in response to a request from a Tenderer, adds or clarifies information to the tender dossier, this information will be sent in writing and shared at the same time with all other Tenderers.
- 9.2 Tenderers should submit their questions by e-mail to [Hun.Tenders@tdh.org](mailto:Hun.Tenders@tdh.org) until **May 5, 2024 at the latest**, specifying **the reference number of this Call for Tenders**.

- 9.3 Tenderers seeking to organise a private meeting with Tdh during the tender period will risk being excluded from the tender procedure.
- 9.4 Tdh may, if necessary, extend the deadline for the submission of tenders to give Tenderers sufficient time to take into account any changes that may be made to the tender dossier.

## 10. Clarification meeting (online)

- 10.1 A clarification meeting will be held on 14 May 2024 at 15pm CET via Teams to answer any questions regarding the tender documents formulated in writing. Minutes will be taken during the meeting and will be communicated in writing to all Tenderers no later than 11 calendar days before the deadline for submission of tenders.
- 10.2 Link to the meeting: [Join the meeting now](#)  
Apart from this meeting, no visits or requests for individual appointments will be accepted from potential bidders throughout the tender period.

## 11. Period of validity of offers

- 11.1 Tenders must remain valid for a period of **120 days from the** deadline for submission of tenders. In exceptional cases and before expiry of the initial period of validity, Tdh may request in writing that this period be extended by **40 days**. Tenderers accepting this request are not authorised to modify their offer. In case of refusal, Tenderers cease to participate in the procedure. The successful Tenderer remains bound by its offer for a period of **90 days from the** date of receipt of the notification informing it that it has been selected.

## 12. Modification and withdrawal of offers

- 12.1 Tenderers may modify or withdraw their tenders by written notification before the submission deadline. No tender may be modified after this date.
- 12.2 Any notification of modification or withdrawal shall be submitted in accordance with Article 7. Withdrawals shall be unconditional and shall terminate all participation in the tendering procedure.

## 13. Opening and evaluation of tenders

### a) Opening of offers

- 13.1 The purpose of opening the tenders is to check whether the tenders are complete, whether the documents have been correctly completed and signed and whether the tenders are generally in order.

- 13.2 The bid evaluation committee will not take an immediate decision on the admissibility or inadmissibility of bids at the time of bid opening.
- 13.3 Tenders will be opened on 21/May/2024 14.00pm CET by an evaluation committee composed of representatives of Tdh.
- 13.4 After the opening of the tenders, no information relating to the examination, clarification, evaluation and comparison of the tenders and recommendations concerning the award of the contract will be disclosed until the contract has been awarded.

b) Administrative evaluation

- 13.5 The purpose of this stage is to verify the conformity of the tenders received, in terms of substance and the requirements of the tender documents. A tender is deemed to be compliant when it complies with all the conditions, terms and specifications contained in the tender documents, without any significant deviations or restrictions. Substantial deviations or restrictions are those which affect the scope, quality or performance of the contract, or which substantially depart from or limit the rights of the contracting authority or the obligations of the Tenderer under the contract and adversely affect the competitive position of Tenderers who have submitted compliant tenders. Tenders that are administratively found to be non-compliant will be rejected and will not proceed to the technical evaluation stage.

c) Technical evaluation

- 13.6 In order to be considered technically compliant, the offer must meet or exceed the required conditions and technical specifications without significant deviations or restrictions.

Any bid that is clearly not suitable and capable of providing the services requested in the call for tenders will be excluded from the selection process. Bids that are found to be technically non-compliant will not be evaluated financially.

d) Financial evaluation

- 13.7 The financial evaluation aims to identify the lowest bid among the technically compliant bids.

e) Request for clarification

- 13.8 During the evaluation process, in the interests of transparency and equal treatment, the evaluation committee may ask Tenderers, in writing, to clarify their tender within a reasonable period of time, without them being able to modify it. None of these requests for clarification must be aimed to correct any initial errors or failures affecting the performance of the contract or distorting competition.

f) Criteria for awarding the contract

- 13.9 The contract will be awarded to the tender that is both **technically** and **administratively compliant** and **most economically advantageous**, taking into account the quality and price of the services offered.

Offers will be evaluated according to the criteria listed below:

- Ability to meet the conditions required by present Call for Tenders
- Compliance with Tdh terms and conditions
- Quality of/feedback from References provided
- Quality of the approach and methodology proposed
- Price competitiveness
- Turnaround time of service requests
- Additional services/customer benefits offered.

#### 14. Signature of the contract

- 14.1 Within three (3) working days following receipt of the contract, the selected Supplier must sign, date and return it to Tdh.
- 14.2 If the successful Tenderer does not return the signed contract within three (3) working days, Tdh may, after notification, consider the award null and void and award the contract to the second place Tenderer.
- 14.3 Unsuccessful Tenderers will be informed by e-mail within 10 days from the date of award of the contract.
- 14.4 The successful Tenderer will be informed by e-mail that their offer has been accepted. Before the contract is signed between the contracting authority and the successful Tenderer, the latter must provide the documentary evidence or declarations required by the legislation of the country where the company (or each company in the case of a consortium) is established which are not already provided with the tender documentation. Such evidence, declarations or documents must bear a date which may not be more than one year prior to the date of submission of the tender.
- 14.5 If the successful Tenderer does not provide these documents within 10 calendar days of notification of the contract award or if it is found that he has

provided false information, the contract award shall be considered null and void.

## 15. Cancellation of the tender procedure

15.1 In particular, a cancellation may occur when:

- the tender procedure was unsuccessful, i.e. when no adequate, qualitatively or financially acceptable offer was received or when there was no valid reply;
- the technical or economic elements of the project have been fundamentally modified;
- exceptional circumstances or force majeure make the normal execution of the project impossible;
- all technically acceptable offers exceed the available budget;
- substantial errors, irregularities or acts of fraud have been found in the course of the process, in particular where they have prevented fair competition.
- where the price proposed by the Tenderer to whom the contract is to be awarded is objectively disproportionate to the contract price.

**Under no circumstances can Tdh be held liable for any damages whatsoever, including and without limitation, damages for loss of profit, related in any way to the cancellation of the tender procedure, even if the contracting authority has been informed of the possibility of damages. The publication of a contract notice does not commit the contracting authority to implement the programme or project announced.**

## 16. Ethics

Failure to comply with the following ethical rules will result in the immediate exclusion of the Tenderer from this procedure:

(a) Child labour

Child labour is prohibited by international conventions. As such, no child under the age of 18 may work directly or indirectly for a contract signed with Terre des hommes.

b) Exploitation/slavery

The working conditions of the employees of the holder of contracts signed with Terre des hommes must comply with the regulations in force in the country, in particular with regard to minimum wages and working hours. In the absence of these regulations, working conditions must be downgraded and wages must be equivalent to the average

wages practiced in the area. Any physical constraints or sanctions against employees are excluded.

(c) Links with the production and trade of anti-personnel mines

In compliance with the international treaty banning anti-personnel mines (the Ottawa Treaty), no contractor will be able to claim a contract with Terre des hommes if it is proven that the latter participates in any way whatsoever in the spread of anti-personnel mines (production, trade, assets, shareholders, transport, storage, etc.). In this precise case, any contract awarded may be terminated immediately by Terre des hommes without the contractor being able to claim any compensation whatsoever.

(d) Links with weapons trade

In respect of our status as an international solidarity organisation, no company or supplier can claim to do business with Terre des hommes if it is proven that it participates in any way whatsoever in the weapons trade (production, trade, assets, shareholders, fundraising, transport, storage, etc.).

(e) Links with terrorist networks

No company or supplier may claim to carry out a contract with Terre des hommes if it is proven that the latter has links, in any form whatsoever, with terrorist networks of any kind (acts of violence perpetrated against civilian populations or civilians installations committed by an organisation).

f) Respect for the environment

Terre des hommes market holders must strive to use production techniques and processes that respect the fundamental rules of environmental protection, (mainly with regard to deforestation and the use of chemical agents affecting the protection of biodiversity).

g) Conflict of interest

No employee or member of Terre des hommes may accept or solicit any gratuities, favours or personal benefits related to his or her position or contracts. Similarly, no company or supplier may claim to carry out a contract if there is a direct family or interest link with a member of the staff of Terre des hommes.

h) Practices of Corruption, Fraud, Collusion or Coercion

Terre des hommes will reject any proposal made by Tenderers, suppliers or candidates, if it is established that they have engaged in practices of corruption, fraud, collusion or coercion. In such a case, Terre des hommes will terminate their contract.

## 17. Situations of exclusion

- 17.1 Tdh will exclude from this procedure any Tenderer in one of the following situations:
- a) they are bankrupt or being wound up, are having their affairs administered by the courts, have entered into an arrangement with creditors, have suspended business activities or are in any analogous situation arising from a similar procedure in national legislation or regulations;
  - b) have been convicted by a judgment having the force of res judicata for any offence committed in the exercise of his professional activity.
  - c) they have been guilty of grave professional misconduct proven by any means which the contracting authorities can justify.
  - d) not having fulfilled obligations relating to the payment of social security contributions or taxes in accordance with the legal provisions of the country of registration in which he is established or with those of the country of the contracting authority or those of the country where the contract is to be performed.
  - e) have been the subject of a judgment which has the force of res judicata for fraud, corruption, participation in a criminal organisation, money laundering or terrorist financing, or any other illegal activity detrimental to the Communities' financial interests;
  - f) have been declared to be in serious breach of contract in a previous procurement procedure for failure to comply with its contractual obligations;
  - g) candidates who are subject to a conflict of interest;
  - h) be guilty of misrepresentation.
  - i) have been guilty of attempting to influence the evaluation committee in the process of examining, clarifying, evaluating and comparing tenders, obtaining information on the progress of the process or influencing Tdh in its decision on the award of the contract.
  - j) have tendered for more than one offer either individually or as a partner in a joint venture/consortium. The participation of a Tenderer in more than one tender will result in the disqualification of all tenders in which the Tenderer is involved in this procedure.
  - k) be guilty of exploitative child labour or other forms of human trafficking. It must in any case respect the fundamental social rights and the dignity of working conditions of everyone in its enterprise but also with the subcontractors with whom it works in the course of its activities.
  - l) be in one of the situations mentioned in the "Ethics" article of this document.

## 18. Subcontracting

- 18.1 Subcontracting will not be accepted except in exceptional circumstances and with the prior authorisation of Tdh.

## **19. Eligibility**

- 19.1 Participation in the call for tenders is open equally to all natural or legal persons and companies. However, in order to comply with the rules of some of the donors who finance Tdh programmes, participants in the call for tenders will have to clearly stipulate in their tender the nationality of their company and the origin of the products offered.

### **Terre des hommes**

Terre des hommes (Tdh) is Switzerland's largest children's aid organisation. Since 1960, Tdh has been helping to build a better future for children and their communities through innovative and sustainable solutions. Active in nearly 40 countries, Tdh works with local and international partners to develop and implement projects on the ground that improve the daily lives of more than four million children and members of their communities.

Terre des hommes in Hungary – which operates as the Regional Hub of Terre des hommes for Europe - has developed a knowledge portal for child protection professionals in South East Europe, called the [Child Protection Hub](#). This has grown into a mature, rather large and popular website in 8 languages, which has also become a model for further knowledge portals for various subjects. Tdh in Hungary currently has a staff of 5 editors who are communications professionals and are working with these various websites. In addition there are 3-5 volunteers from other countries who also may be doing uploading.

Besides ChildHub, the [Safeguarding Resource and Support Hub](#) (in collaboration with Social Development Direct, and owned by FCDO) has been operational since 2020 on safeguarding in the aid sector, the [UEFA-Safeguarding website](#) (run in collaboration with UEFA) serves the football community to improve child safeguarding practice. [LocalLink Hub](#) is running on a subdomain of ChildHub – and so if fully integrated into it, while the languages, the taxonomy is somewhat different.

The one **new** website development may be for Tdh's collaboration with the International Golf Federation. At the moment of writing it is not confirmed that this will come to fruition, so there are no information available on specification, design, structure, taxonomy, etc. The only information available is that it should be structured similarly to the UEFA-Safeguarding website, will be multi-lingual, and should also include an LMS as well as CMS.

At the writing of this document, this website is not live yet. LocalLink Hub will be designed as a part of Childhub (it will be connected to it and use its domain name).

Target audience: Humanitarian and Development professionals working as in Local and National Partner organisations in the Global South in Bangladesh, Nepal, Hungary, Albania, and India. The website will be scaled up in early 2025 to include more languages and wider audience (all country delegations of Terre des hommes Lausanne).

Objective: Providing knowledge and capacity building solutions, a community space for partner NGOs on Organisational Development, Management and compliance issues as well as other Tdh core expertise topics (Child Protection, Access to Justice, Migration, WASH...)

### **What will LocalLink Hub do?**

1/ Host Capacity Development Sessions of all sorts, including e-learning modules, dedicated to Tdh's partners of any size and status. The Sessions must be, as much as possible, available in English and in the four pilot countries' languages (especially for Nepal, Bangladesh, and Albania to begin with as the Hungary office primarily works with English speaking partners). The sessions may involve

any type of training session that can be hosted on the website: workshops, e-learning courses, or a combination thereof but also videos, audios, Powerpoint, Excel, Word, pdf documents etc.

The capacity building sessions will primarily comprise:

- Technical capacity building sessions related to the Tdh programmatic expertise and aimed at Tdh's partners: Migration, Access to Justice, Health, Child Protection and Child's rights as well as WASH. This can include sessions of all levels, from the basic introduction to the topics to advanced training sessions on specific topics, including transversal issues such as climate change, gender, AAP etc...
- Partnerships and Localisation tools – Finance, HR, Logistics, Compliance tools adapted to the variety of partners that Tdh works with. The tools will also involve a set of Project Cycle Management tools such Monitoring and Evaluation tools, Budget follow-up tools, activity tracking tools.
- Tdh will be able to upload and add content for its local partners use (whether from the country of intervention or for other countries). It will help Tdh organise its Organisational Development with Local and National Partners. The platform must allow partners to upload their own Capacity Building Sessions or Training tools for Tdh and other partners to use (once sent and validated by Tdh staff, field or HQ). This platform must be seen as a two-way Capacity Building Stream where both Tdh partners and Tdh are able to benefit from trainings uploaded on the platform. Each uploaded component will be checked for its quality by Content Manager and HQ Intern (see mention under roles and responsibilities for more information).
- Community space (CoP) for knowledge sharing and networking: the platform users will be granted the right to produce and upload contents on the platform. A selection of pilot partners, based on their experience, capacity, and legal status/country of origin, will be driving the platform's governance.

## CMS & LMS

The existing sites have all been developed in drupal (98% of the code base is from existing modules. As specified in the tender call, applications may be received for only the development – or for development and maintenance as well. For tdh-europe.org close collaboration with Tdh HQ IT will need to be necessary.

ChildHub, RSH, UEFA have LMS systems on moodle as well, where the e-learning courses are running. These LMS are set up already. However, the systems need to be monitored, and some work needs to be done on them: for example new module (scorm file) needs to be added, creating its place, with title, description, certificate, feedback form (texts always provided by Tdh).Also if users signal that they can not access a specific course or have specific problems, assistance may be needed.

## Hosting

All sites, except for the tdh-europe.org are hosted by Pantheon. Tdh-europe site is running on a server hosted by Terre des hommes HQ IT team.

## User experience (UX)

For RSH, LocalLink and IGF it is expected that rounds of user feedback will be asked – these need to be followed-up and necessary adjustments will need to be made. In addition, RSH uses “hotjar” so that we can observe what users do, are there any hick-ups in user experience, as well as we review heatmaps.

In addition, compliance with accessibility is of high importance for Terre des hommes, so WCAG compliance will need to be regularly reviewed for all sites.

Editors of the websites are one community of users – and tickets for small adjustments may come from them.

## **Working Processes**

A common project management tool will be used, where Tdh (client) can identify support needs and bugs, and the supplier can work on them and deliver them to the client. (so far this was “asana”)

Documentation of the sites will need to be maintained regularly.

A test server is available on Pantheon where new code can be tested out before making it live.

Cooperation needs to be maintained with the maintenance company for RSH and ChildHub.

## **Legal Constraints & Contract**

We would like to highlight certain legal points of the future contract that will not be open to negotiation:

### **Material and intellectual property of the website**

The web application created by the service provider will be the property of Terre des hommes. The intellectual property rights attached to the web application will be and remain in any case the exclusive property of Terre des hommes. No intellectual property rights will remain and/or will consequently be held by the provider.

Terre des hommes will have the right to definitively use the web application, for the whole world, for any destination and for any purpose.

In any case, the source codes of the web application will be the property of Terre des hommes.

However, the service provider will be authorised to mention and reproduce the name and logo of Terre des hommes and to report on the work done on these websites to third parties on all the communication media that it wishes to use to promote its activity, without limitation of the territory concerned and without limitation of duration.

## **Data protection**

## ***Annex 2 – Documentation***

### **Technical details of the Childhub website**

#### ***About the platform***

The project has a publicly accessible website which provides access to a range of relevant resources. Additionally, users can register on the website which gives them access to online interactive learning courses which are hosted on a separate Learning Management System (LMS) platform. The website and LMS are linked by a single-sign on authentication system with the website being the master and LMS being the slave in the relationship in terms of login and registration.

This document details the technology setup and hosting platforms for the website and learning platform.

#### ***Hosting and domain***

The main website is hosted on a Pantheon hosted multi-stage environment (dev, test and live). Pantheon is a SaaS (Software as a Service) hosting platform provided by Pantheon.io. There is no operating system level access, with workflow being controlled via composer and git. There is a development, test and live stage environment for each website with integrated security, performance and management features such as global CDN, automated backups etc

Code management is done via GIT with Pantheon also providing a range of integrated workflows including full composer support.

The Moodle platform is hosted by BigWetFish on a cloud VPS which is managed via CPANEL and WHM

#### ***Domain and DNS management***

The project dns is managed by OnlyDomain.

#### ***Website CMS***

The website has been developed in Drupal. Drupal is a free, open-source content management system (CMS) with a large, supportive community. Drupal is open source software released under the GNU Public License.

The website is currently using Drupal 10.2.3, the latest stable release of the CMS. A range of Drupal community contributed modules are used to provide functionality to the website. No custom modules have been used.

The website supports 12 languages with content and interface translation have been integrated via the core Drupal internationalization modules. This allows for content translation and interface translation to be managed via the standard admin interface.

The website includes right to left languages such as Arabic and other non-latin character set languages such as Bangla.

The website has a main Child Protection Hub and an additional LocalLink Hub running as a subdomain of the main Childhub website. Its domain is LocalLink.childhub.org. Multi domain website support is provided by the Domain Access module.

The LocalLink Hub has a unique menu, homepage and design tweaks. Content is shared across both hubs with domain specific content and interface layout presentation managed via Context module.

The main ChildHub website acts as a Progressive Web App with base content for offline access and progressive offline cache. The PWA contributed module has been configured to provide this functionality.

The search-api module has been used for configuration and management of the website views. An external SOLR host, provided by OpenSOLR, is used as the search api solr database. The majority of views on the ChildHub platform are developed off the SOLR index for additional speed and increased search functionality.

### ***Content structure***

There are 27 Drupal content types used on the ChildHub and LocalLink Hub website, all made up of regular field types such as text, image, integer, taxonomy entity etc. Paragraphs module has not been used.

There are currently over 30,000 content items (nodes) in the CMS. 32 taxonomies are used to structure and tag content in the CMS. Some taxonomies (used for content type fields) are relevant to only one Hub, while others are used by both Hubs together.

Taxonomy Access Control Lite (TAC Lite) contributed module has been developed to control access to content according to a taxonomy. If a specific value is selected, the content can only be viewed by users with a specific role. There are currently over 25,000 users registered on the ChildHub platform.

### ***Theming***

The website uses a custom theme developed as a child theme to the contributed Bootstrap project. The LocalLink Hub uses the main theme with some modifications integrated with CSS and JavaScript only.

### ***Analytics***

Google analytics 4 has been used with integration with Drupal CMS via the contributed Google Analytics module. Advanced analysis of user analytics is undertaken using the Supermetrics reporting tool.

### ***Moodle environment***

The Moodle environment uses the 4.2.1 codebase. It uses the core Moodle built-in themes with minimal changes made via CSS and Javascript. The Moodle environment has multi-language support on a per course basis. In addition to the core Moodle plugins it also has Custom Certificate, H5P, Ad Hoc Queries and Reengagement plugins installed.

### ***Other functionalities***

- Mailchimp/mandrill integration for newsletter creation. This allows the user to select content via entity relationship fields which are then injected into Mailchimp templates and campaigns are automatically created and sent via the Mailchimp API. This system supports newsletter creation in 8 languages.
- Mandrill SMTP server integration
- Webform module is used for general contact webforms
- A custom single sign-on has been developed to the Moodle LMS. This is a PHP based SSO with Drupal user data being used to programmatically create Moodle users using the email address as the unique user identifier between both platforms.

## **Technical details of the RSH website**

### ***About the platform***

The Safeguarding Resource and Support Hub (RSH) is a programme that aims to support organisations in the aid sector to strengthen their safeguarding policy and practice against Sexual Exploitation, Abuse and Sexual Harassment (SEAH). RSH supports organisations working in both the humanitarian and development sectors but is driven by the needs of smaller national or local organisations in developing countries.

The project has a publicly accessible website which provides access to a range of relevant resources. Additionally, users can register on the website which gives them access to online interactive learning courses which are hosted on a separate Learning Management System (LMS) platform. The website and LMS are linked by a single-sign on authentication system with the website being the master and LMS being the slave in the relationship in terms of login and registration.

This document details the technology setup and hosting platforms for the website and learning platform

### ***Hosting and domain***

The main website is hosted on a Pantheon hosted multi-stage environment (dev, test and live). Pantheon is a SaaS (Software as a Service) hosting platform provided by Pantheon.io. There is no operating system level access, with workflow being controlled via composer and git. There is a development, test and live stage environment for each website with integrated security, performance and management features such as global CDN, automated backups etc

Code management is done via GIT with Pantheon also providing a range of integrated workflows including full composer support.

The moodle platform is hosted by BigWetFish on a cloud VPS which is managed via CPANEL and WHM

### ***Domain and DNS management***

The project dns is promanaged by CloudFlare. Cloudflare also provides a range of other functions supporting the website including firewalls, dns proxy and a full content proxy.

### ***Website CMS***

The website has been developed in Drupal. Drupal is a free, open-source content management system (CMS) with a large, supportive community. Drupal is open source software released under the GNU Public License.

The website is currently using Drupal 10.2.3, the latest stable release of the CMS. A range of Drupal community contributed modules are used to provide functionality to the website. No custom modules have been used.

The website support 18 languages with content and interface translation have been integrated via the core Drupal internationalization modules. This allows for content translation and interface translation to be managed via the standard admin interface. The website includes right to left languages such as Arabic and other non-latin character set languages such as Bangla.

The website has a Global Hub and a range of integrated National Hubs running as subdomains of the main safeguardingsupporthub.org. For example the Nigeria Hub is nigeria.safeguardingsupporthub.org. Multi domain website support is provided by Domain Access module.

Each Hub has a unique menu, homepage and design tweaks. Content is shared across multiple hubs with domain specific content and interface layout presentation managed via Context module.

The main Global Hub website acts as a Progressive Web App with base content for offline access and progressive offline cache. The PWA contributed module provided this functionality.

The search-api module has been used for configuration and management of the website views.

## ***Content structure***

There are 18 Drupal content types used on the RSH website, all made up of regular field types such as text, image, integer, taxonomy entity etc. Paragraphs module has not been used.

There are currently over 3,000 content items (nodes) in the CMS. 20 taxonomies are used to structure and tag content in the CMS

## ***Theming***

The website uses a custom theme developed as a child theme to the contributed Bootstrap project. Each National Hub uses the main theme with some modifications integrated with CSS only.

## ***Moodle environment***

The Moodle environment uses the 4.2.1 codebase. It uses the core Moodle built-in themes with minimal changes made via CSS and Javascript. The Moodle environment has multi-language support on a per course basis. In addition to the core Moodle plugins it also has Custom Certificate, H5P, Ad Hoc Queries and Reengagement plugins installed.

## ***Analytics***

Google analytics 4 has been used with integration with Drupal CMS via the contributed Google Analytics module. Advanced analysis of user analytics is undertaken using the Supermetrics reporting tool.

## **Technical details of the TDH Europe website**

### ***About the platform***

The project has a publicly accessible website which provides access to a range of relevant resources. Users cannot register on the website, authenticated users are restricted to content editors and site administrators.

This document details the technology setup and hosting platform.

### **Hosting and domain**

The main website is hosted on a server hosted by the TDH HQ ICT Team in Lausanne. There is no operating system level access, with workflow being controlled via SFTP and PHPMyAdmin. There is only a live stage environment.

Code management is done via SFTP with TDH HQ ICT Team being responsible for the availability of the platform, security updates to the server operating system and backups..

### **Domain and DNS management**

The project DNS is managed by the TDH HQ ICT Team in Lausanne.  
Website CMS

The website has been developed in Drupal. Drupal is a free, open-source content management system (CMS) with a large, supportive community. Drupal is open source software released under the GNU Public License.

The website is currently using Drupal 10.2.3, the latest stable release of the CMS. A range of Drupal community contributed modules are used to provide functionality to the website. No custom modules have been used.

The website supports 2 languages with content and interface translation have been integrated via the core Drupal internationalization modules. This allows for content translation and interface translation to be managed via the standard admin interface. The website does not include right to left languages or non latin alphabet language support.

The search-api module has been used for configuration and management of the website views.

### **Content structure**

There are 9 Drupal content types used on the website, all made up of regular field types such as text, image, integer, taxonomy entity etc. Paragraphs module has been used for content structure and design of some content types.

There are currently approx 150 content items (nodes) in the CMS. 6 taxonomies are used to structure and tag content in the CMS

## **Theming**

The website uses a custom theme developed as a child theme to the contributed Bootstrap project.

## **Analytics**

Google analytics 4 has been used with integration with Drupal CMS via the contributed Google Analytics module. The google analytics account is managed by the TDH HQ ICT Team in Lausanne

- Geofield has been used to geotag content and display that content on an interactive map via views
